Dear Friend: By the time you receive this mailing, a draft response to Okemo’s proposed expansion at Mount Sunapee from Commissioner Jeffrey Rose (Department of Resources and Economic Development) may have been announced, or will be soon.

While the resort operator argues that expansion will bring skier and economic benefits, the State has yet to address an array of significant concerns including legal, environmental, and public trust considerations.

Recently the Concord Monitor (12/28/2014) and Valley News (1/15/2015) editorialized that the **State should say “No” to expansion.** The Friends of Mount Sunapee agrees. Read the editorial and get more information at our website: **www.FriendsofMountSunapee.org.**
